What duties can carry out? How old must volunteers be?

Almost all functions of the railway are carried out by volunteers at the RMR volunteers, from Trustees of our charitable Trust, to engine drivers, guards and administrators.

We do not have any opportunities for new volunteers under the age of 18.

There is no maximum age but there are medical fitness criteria for safety critical railway duties.

I would like to be an engine driver. Could I do this straight away? All our personnel undertaking safety critical railway duties must first undertake training and assessment procedures required by our safety regulator – details are shown on page two.

For volunteers showing aptitude and commitment, we can soon provide the experience and training to obtain the skills required for railway operating.

Are there volunteer opportunities other than for railway operators?

Yes there are; we would particularly like to hear from potential volunteers who would enjoy engaging with visitors in our museum or shop.

We would also like to enlarge our engineering team who restore the trains and keep them running.

Why volunteer at Rhyl Miniature Railway?

We encourage a friendly atmosphere at the RMR as we have found that happy staff lead to happy visitors. We also offer our volunteers unlimited supplies of tea and coffee.

When do volunteer activities take place? During the railway operating season we are present on the days shown on our timetable. Out of season we are often present on at least one day in every weekend.

If I volunteer can I come and go as I please?

We welcome volunteer support at any time. However, if we know when you intend to come and what you would like to do, that gives us a better chance to schedule a rewarding volunteer experience for you. We normally plan railway operating duties in whole days from 10am to 5pm.

I would like to volunteer, who do I contact and what happens next?

Please contact us at Central Station or use the contact page on our website. On arrival we will ask you to fill out a form and we will provide induction.

If you wish to undertake safety critical duties you must wear safety footwear, which we will help to provide if necessary.
